## 4-H PRESIDENT AND REGIONAL VICE PRESIDENT

**State Council President:** The President of 4-H State Council serves as a statewide ambassador for 4-H and a representative of Alabama youth.

The duties of the **President** include:

1. Serving as a voice for Alabama’s young people
2. Presiding at all meetings of 4-H State Council
3. Providing general leadership and direction for state council activities
4. Representing Alabama 4-H before other organizations and agencies
5. Serving as a member of the Board of Directors for the Alabama 4-H Club Foundation

Membership on the 4-H Foundation Board requires a major time commitment. The President is a voting member of the board and is the sole youth voice on the board. The President must attend four one-day board meetings each year. These are on Thursdays and require that he or she miss a day of school. The president also serves as a member of the program committee of the board.

**Regional Vice President North District, Regional Vice President Southwest district, Regional Vice President Southeast District:**

The duties of the Regional **Vice Presidents** are:

1. Representing the voice of Alabama’s youth
2. Presiding over meetings when the president cannot
3. Assisting the president as needed
4. Representing Alabama 4-H to other organizations and agencies within his or her region
5. Chairing Council committees, as needed
